Dear Friends of Georgian Court University,

“It was the best of times, it was the worst of times.” The 2008–2009 Centennial year was noted for many incredible events that celebrated our 100-year history. We welcomed a steady stream of distinguished guests, and our students heard from acclaimed poets, social justice advocates, and literary giants. We honored scholarship, teaching, and the Mercy core values.

Two highly significant academic successes continued our progress toward distinction in the academy. We successfully completed our Middle States evaluation and visit, and the School of Education distinguished itself in gaining national accreditation by the Teacher Education Accreditation Council (TEAC).

However, we weren’t just content to reflect on our past. We *made* history, too. The Court celebrated a new series of “firsts” as our inaugural class began studies in the Georgian Court-Meridian Health School of Nursing, and the Lions soccer team made their first NCAA Division II championship appearance. At the same time, our volleyball team saw its first NCAA tournament victory, our softball team was one win away from appearing in the NCAA Division II World Series, and GCU became the first campus in New Jersey to buy all of its electricity from renewable resources.

These were the positive headlines. Amidst these reasons for celebration came the economic crisis of our lifetime. While we celebrated history and accomplishment, we were adjusting budgets and plans to cope with the extraordinary financial challenges as Wall Street and the American economy spiraled downhill. These challenges

included reduced revenue from anticipated enrollment and fund-raising and the increased need for financial assistance to our students, many of whom are the first in their families to attend college.

Georgian Court had to respond—quickly and responsibly. We put students first to create additional student aid so fewer students would have to give up their dream of a Mercy education. We trimmed budgets and asked faculty and staff to do more with less. We cut costs and looked for creative ways to save money so that we could make the most of every penny that goes into equipping GCU students with the knowledge and skills they will need to succeed in the new economy.

Thankfully, we received confirmation from Moody’s that our bond rating at BBB+ remains stable. We steadied the ship and stayed on course to deliver the hallmark, values-based education that continues to transform lives, just as it did in 1908.

God has blessed Georgian Court through both tough and prosperous times during our 100-year history. Our strong faith, unwavering commitment to educational excellence, and the generosity of our donors to the Mercy mission gives us renewed hope for the future.

Highlights of the GCU Centennial Year

✿ *Mercy Day, September 24, 2008, launched the opening of Georgian Court University's 100th birthday celebration. The new \$26-million Wellness Center was officially opened and dedicated. Mary Waskowiak, RSM, president of the Institute of the Sisters of Mercy of the Americas, keynoted the event with an audience of more than 700 guests.*

✿ *The Mercy Service Marathon invited students, staff, and alumni to put the Mercy core values into action in the community by volunteering time and energy to more than 21 participating community organizations and 42 other worthy causes resulting in over 1,000 hours of service over a three-month period.*

✿ *A Centennial Women's Leadership Conference was held in March 2009 with more than 650 people in attendance. A nationally renowned group of women led three panel discussions on women in business, women in politics and the media, and women in education. Keynote speaker Marian Wright Edelman, founder and president of the Children's Defense Fund, delivered a speech on "Charting a Course for the Next Generation."*

✿ *Scholarship Day, a Centennial celebration of scholarship and creativity, was held in March 2009 with 45 panel presentations from faculty and students spanning the four schools and all departments. A special Convocation featuring keynote speaker Father Daniel Berrigan, SJ, highlighted the day. Father Berrigan, who was awarded an honorary doctorate at the ceremony, was a leader in the antiwar movement, and is known for his writing and poetry.*

✿ *The Court of Honor commemorated the first 100 years of Georgian Court University by honoring 100 notable alumni. The 2008 Court of Honor begins a tradition of recognizing graduates whose record of service, leadership, and achievement within a particular discipline, organization, or cause has brought distinction to Georgian Court.*

✿ *McAuley Community Center programs and events featured special Centennial events ranging from famed Irish tenor Dr. Ronan Tynan, lectures from bestselling author James McBride, poet Billy Collins, and social activist Naomi Tutu, daughter of Desmond Tutu.*

✿ *Two award-winning issues of the Georgian Court University Magazine (Fall 2008 and Spring 2009) commemorated the Centennial with historic timelines, an overlay map showing how the campus has grown, and reminiscences from faculty and alumni.*



Year-End Highlights of 2008–2009

❁ *The Middle States re-accreditation process, which started in 2006, was successfully concluded with official notification that read, in part, “To reaffirm accreditation and to commend the institution for progress to date and for the quality of the self-study process.”*

❁ *The university initiated a Learning Commons Committee, which developed a working definition of the GCU Learning Commons, a new centerpiece academic building. A subcommittee created a design plan involving the renovation of the Arts and Science Center and the addition of a 48,000-square-foot new academic building.*

❁ *A university-wide planning group developed action plans with specific tasks and measurable outcomes (Key Performance Indicators—KPIs) for the Georgian Court University Strategic Plan.*

❁ *A planning committee was created to establish the Mercy Institute. The institute will establish Georgian Court University as an academic center for serious inquiry into the concept and practice of mercy and reflective study of the Mercy core values.*

❁ *University enrollment increased from 3,045 in 2007 to 3,189 in 2008.*

❁ *Undergraduate full-time freshmen and transfers increased from 425 in 2007 to 527 in Fall 2008.*

❁ *Summer/Fall 2008 graduate student credits increased from 3,605 to 4,207.*

❁ *The first incoming class of undergraduate nursing students to the Georgian Court-Meridian Health School of Nursing began their studies in Fall 2008.*

❁ *Georgian Court became the first higher education institution in New Jersey to purchase all of its electricity from renewable resources. GCU purchased approximately 6,122,000 KWh of wind power, an amount equivalent to the university’s annual electrical power usage, in the form of Green-e certified Renewable Energy Certificates (RECs).*

❁ *The university received an Honorable Mention in the 2008 New Jersey Clean Energy Leadership Awards from the Board of Public Utilities.*

❁ *GCU was awarded membership in the Green Power Leadership Club from the Environmental Protection Agency’s Green Power Partnership program.*

❁ *Georgian Court was a NJ BIZ Green Leadership Award finalist.*

❁ *The university participated in the national Recyclemania competition for the third consecutive year with our best results to date (34th of 200 nationally and 2nd of 9 in New Jersey).*



❁ *Track and field became the eighth NCAA Division II sport at GCU, with student-athletes benefitting from the brand new eight-lane track.*

❁ *The soccer team won the 2008 CACC Championship and made their first-ever appearance in the NCAA Division II Women's Soccer Championship Tournament.*

❁ *The softball team won the 2009 CACC championship, coming within one victory of a trip to the NCAA Division II World Series after winning the NCAA East II Region and advancing to the NCAA Super Regionals for the first time in program history.*

❁ *The volleyball team earned the program's first-ever NCAA Tournament victory with a win in the 2008 NCAA Division II Women's Volleyball Championship Tournament.*

❁ *The university enhanced relations with scholarship donors.*

❁ *The 1908 Society was established to support an endowed scholarship fund.*

❁ *The Beyond the Court alumni mentorship program was created, bringing alumni together with GCU students to create a valuable network dedicated to continuing career success.*

❁ *The Trocaire Council for former trustees was initiated.*

❁ *Georgian Court was awarded \$188,100 by the U.S. Department of Health and Human Services to support activities for an autism institute.*

❁ *The Centennial Ball (GCU's 11th Annual Scholarship Gala) and the Centennial (our 14th annual) Golf Classic were held.*

❁ *The university raised \$1.2 million in annual operating support.*

❁ *Georgian Court's teacher education and administration and leadership programs gained national accreditation by the Teacher Education Accreditation Council (TEAC), certifying that these programs have provided evidence of adhering to TEAC's quality principles.*

❁ *An Integrated Academic and Student Life Framework was developed to provide students with multiple opportunities to grow in mind, body, and spirit.*

❁ *The GCU Web site implemented a social media Web 2.0 plan that included student blogging, a Facebook presence, FlickrR, and Twitter.*

❁ *The university received 14,188 column inches of media coverage of GCU faculty, programs, and events valued at \$534,470.*

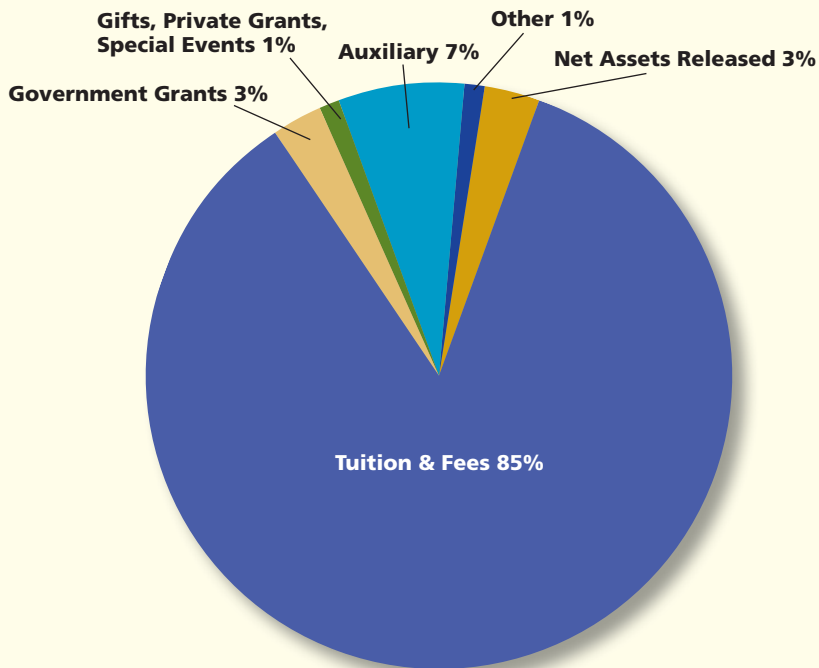

Fiscal Notes

Stable student demand and our strong market position as a Mercy, liberal arts university positioned Georgian Court well for the 2008–2009 fiscal year. Like many private universities in New Jersey, Georgian Court was not immune to the turmoil in the financial markets. The tightening of the credit market made it difficult for many of our students to obtain student loans. Because 51 percent of our students are first in family to attend college, many families were experiencing significant financial distress.

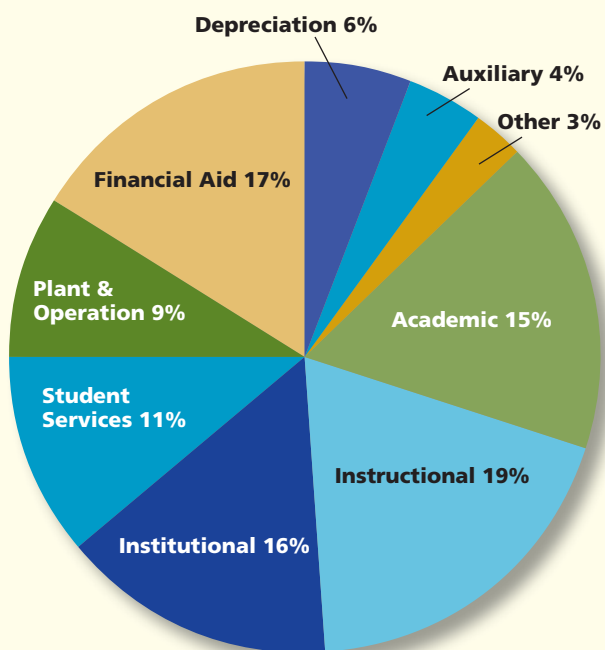
This personal financial stress and credit crunch created the need for additional financial aid and counseling. Through the efforts of faculty and staff, we were able to retain many of our students who might otherwise have been forced to “step out” for the spring semester and put their educational dream of a Mercy education on hold.

The operating budget ended the fiscal year with a deficit of \$783,638 due to the need for increased student aid, a significant shortfall in summer revenue, and fewer resident students than projected.

The activity of the long-term investments during the fiscal year was subject to the market volatility experienced by many college and university endowments. However, prior diversification, conservative investing, and work with SEI, our investment management firm, helped to mitigate the impact to the university’s investment portfolio.

The university’s planned giving charitable annuity program was managed by Wachovia Wealth Management. This company’s acquisition by Wells Fargo had no impact upon the university’s gift annuity program. The university is in the second year of a three-year commitment to invest with Leviticus for socially responsible investing. The university’s long-term investment portfolio as of June 30, 2009, was valued at \$33,594,456. The university ended the fiscal year with total unrestricted net assets of \$58,610,769 and total net assets of \$73,369,790.
